- Lab investigation report should be maintained properly in case records.
- All follow up attendance should be recorded on the case records.
- Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

As Central Government by notification, constituted the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

"Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act".

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. All admissions in undergraduate courses shall be through NEET and the list of candidates selected category wise may be informed to the National Commission for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Board as per rules and penalty as decided by Commission will be imposed.
- 6. The college has to comply with the full requirements of HCC (MSR) Regulations, 2013 and as amended from time to time for conducting the course.
