

K.E.S Loknete Adv . Datta Patil Homoeopathic Medical College and Hospital, Balasaheb Khardekar Road, Vengurla, Bhatawadi, Dist. Sindhudurg-416516 with intake capacity of 50 seats has applied for permission for conducting BHMS course for the A.Y. 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board have observed following shortfalls.

a) Miscellaneous

- · Aadhar enabled biometric attendance system(AEBAS) is not implemented. This may enabled within a period of one month.
- Form 16 is not uploaded by the faculty. Form 16 from traces portal of all the faculty shall be submitted for verification.
- Attendance register of staff with signature is not legible. A legible copy of the same may be submitted.
- Acquittance and Attendance of guest faculty is not uploaded. College shall submit attendance and Acquittance of guest faculty and modern consultant of medicine for past 3 months.
- Acquittance Of Dr Dr. Sangita Atul Mule, Dr. Satish Sambhaji Patil, Dr. Satish Sambhaji Patil, Dr. Shreeram Prabhakar Hirleka, Dr. Rakhi Subodh Madhav, Dr. Rashmi Rajshekhar Karlekar, Dr. Mohan Pandurang Jagtap, Dr. Anil Ganpatrao Vankudre, Dr. Anil Ganpatrao Vankudre, Dr. Anil Ganpatrao Vankudre From Full Time Faculty Are Not Uploaded.

b) Hospital

I.P.D and O.P.D Case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, and Phone numbers with complete case history analysis, evaluation and repertorisation. These documents and follow up attendance of the patients shall be made available in the Medical Record Room for academic purpose of students. All cases shall be diagnosed as per ICD 11 criteria.

Considering the above observations and facilities available, MARBH has decided to issue Conditional Permission for K.E.S Loknete Adv. Datta Patil Homoeopathic Medical College and Hospital, Balasaheb Khardekar Road, Vengurla, Bhatawadi, Dist. Sindhudurg-416516 functioning with intake capacity of 50 seats in BHMS course for the A.Y. 2024-25

All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET qualified candidates only. It is further informed th'at minimum 15% of seats of the permitted intake capacity of 50 seats for BHMS course shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT Govt. as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
